2. INTRODUCTION

In order to focus attention on various issues relating to heritage conservation in the region, the MMRDA in its meeting held on 30th May, 1996 approved the proposal to establish the MMR-Heritage Conservation Society. Accordingly, the MMR-Heritage Conservation Society was registered under the Societies Registration Act, 1860 on 14th November, 1996 and the Mumbai Public Trust Act, 1950 on 6th February, 1997.

The jurisdiction of the Society is the Mumbai Metropolitan Region (MMR) area. Project proposals are invited in the format prescribed by the Society from local bodies, university, colleges, societies, institutions, voluntary organizations, NGOs and intellectual individuals working in the field of heritage conservation.

3. OBJECTIVES OF THE SOCIETY

The main objectives of the MMR-Heritage Conservation Society are – to promote preservation, conservation, protection, development and improvement of natural, built and related cultural heritage within the area of Mumbai Metropolitan Region (MMR); and to adopt all means to achieve the objects incidental or ancillary to the attainment of the main objects including but not restricted to the following:

a) Developing a Data Base for MMR


- To conduct studies/surveys of buildings, artefacts, structures and precincts of historical/ aesthetic / architectural / cultural value;
- To undertake systematic listing of heritage buildings and precincts as well as identifying the components of natural / cultural heritage which needs to be conserved;
- To compile and store data on heritage, including digital database conversion by using advanced techniques such as computerized optical image processing;
- To set up a full-fledged resource centre including library, material documentation and photo-documentation centre on heritage conservation.

b) Training, Education and Awareness

- To encourage the architectural educational institutions by undertaking training programmes in heritage conservation & carrying out documentation of heritage buildings and precincts in MMR;
- To organize training programmes for local authorities for developing capabilities in undertaking heritage conservation related activities;
- To sponsor candidates for participating in training courses in India/abroad for architectural students and local authority staff in heritage conservation and related subjects;
- To publish a journal and organize other publications on various aspects related to heritage conservation;
- To promote awareness about heritage conservation movement by educating general public as well as students at the school level, by organizing exhibitions/competitions on heritage conservation.

c) Providing Financial Assistance to Conservation

- To finance the programmes for maintenance of heritage buildings/precincts/ artefacts;
- To finance the programmes leading to preservation and conservation of natural heritage such as coastal areas, lakes, rivers, forests, hills and hill stations etc.;
- To finance the programmes of preservation and conservation of settlements of cultural and historical significance;
- To promote networking of various agencies in MMR including local historical societies, NGO's and professionals.




















4. OVERVIEW OF SOCIETY'S ACTIVITIES (1996-2017)

During the last 21 years, the MMR-Heritage Conservation Society has supported **75** projects, involving survey, documentation, conservation guidelines for major heritage buildings and precincts and implementation of actual conservation/ restoration of heritage structures and the grant approved for these projects was **Rs. 7.83 crores.** The Society has so far released financial assistance of **Rs. 6.75 crores** for the projects up to 31/03/2018.

i. Heritage Listing

The Society has commissioned the review of the existing heritage list of Greater Mumbai and the identification of new heritage structures for preparation of new list for the entire MMR. The Society has identified 2700 heritage properties which includes 101 precincts.

The aim of the project was establish collaboration with the residents of the precinct for preparing suitable policy guidelines, ensuring wider participation in the process. It aimed to update the existing database available for the precinct, interpret and analyze the collected data and prepare guidelines to facilitate urban transformation in conjunction with the existing architectural and urban fabric.

The precinct was divided in two distinct zones- the Core zone and the Buffer zone. Surveys were conducted to map aspects such as open spaces and built form pattern, traffic pattern, building heights, use, age, condition, ownership, physical transformation. Architectural documentation was undertaken to study architectural features and understand the influences and evolution of the typology of houses. The final outcome- conservation guidelines along with development regulations to regulate development and conserve precinct were prepared with par-





5. ACTIVITIES DURING THE YEAR 2017-18

5.1 NEW PROJECT PROPOSALS

During the year 2017-18, the Society received eleven project proposals for funding, which were scrutinized by the Sub-Committee of the Society. One proposal is under consideration, on the recommendation of the Sub-Committee, the Board of Governors rejected six proposals; and approved the following four project proposals for funding:

(a) "Heritage Signs and Street Furniture for MMR: Phase 1 - Preparation of Design Manual with guidelines for street furniture and signages and design details for a precinct" by A & A Design Associates, Mumbai

Date of Approval: 27 July 2017 Project Grant: Rs. 15,09,600/-Project duration: one year

The project aims to create signage/street furniture for the heritage sites in MMR. It aims to create design guideline manual for signage/street furniture with sensitivity towards Heritage style, sizes, placement, mounting details, illumination, choices of appropriate materials, and fabrication/construction for further reference for all the ULBs of MMR.

The proponent has completed Stage One of the project- Reconnaissance & Research, which included conducting site visits and on-ground work to develop insights on the structures and precincts across all 17 ULBs, detailed study of selected precinct for pilot project, synthesis of MMR-HCS database, study of international Heritage Signage and Street furniture guidelines and design, literature review etc. The team have made 16 site visits, eight in Thane district and eight in Raigad district. The trips were planned on the basis of MMR heritage lists and research publications, with emphasis on different typologies- residential, mercantile, religious, forts, jetty, dams, Zila Parishad Schools etc.



A total amount of Rs. 7,54,800/- has been released so far.

(b) "Heritage Architecture and Community: Documenting community and belonging in Heritage sites" -

by Dr. Alka Hingorani, IDC, IIT Mumbai

Date of Approval: July, 2017 Project Grant: Rs. 11,00,000/-Project duration: Seven months

The proponent aims to study the historical sites in Mumbai to understand the impact that the heritage nature of the location has on the people. The project aims to investigate the influence of heritage structures and localities on the communities and their everyday lives and vice versa. The scope of work consists of secondary research, primary research through ethnographic interviews etc and the outcome of the project includes two micro documentaries and two essays. Banganga and Mahatar Pakhadi are the two sites selected for documentation.

The proponent has shared two excerpts from the documentary on Banganga. The team has started work on the second site and aims to complete the project by July 2018. A total amount of Rs. 6,23,750/- has been released so far.

(c) "Heritage Education: What, Why & How"-

by Mr. Prashant Mahajan, Somaiyya Vidyavihar

Date of Approval: July, 2017 Project Grant: Rs. 10,14,000/-Project duration: one year

The project aims to increase heritage literacy and awareness through a site-based experiential learning programme, aimed at children, especially economically underprivileged youth from the age group 11-15 years. It is envisaged in three phases. Phase 1- Heritage Education workshop is a three day interactive training for teachers. It will include a field visit on day-2, on one of the heritage precincts, to create lesson plans based on the historic site. On day-3, these lesson plans will be reviewed and refined and implemented in Phase 2- Experimental Phase. In this phase, teachers will conduct workshops for their respective school students based on the lesson plans prepared during Phase 1. Written feedback will be obtained from students to further improve the course. In Phase 3, two meetings will be conducted to review the process of designing and implementing the lesson plans.

An advance amount of Rs. 3,04,200/- being the first installment, has been released so far and the first stage of the project is yet to be reviewed.

(d) "The Heritage Handbook- Mumbai Island City"-

by Nisha Nair, People Place Project LLP, Mumbai

Date of Approval: February 2018 Project grant: Rs. 2,51,000/-Project duration: Eight months

The project is conceived and designed to be a handbook of around 50 pages, for an explorer of heritage. It will be an exhaustive and comprehensive heritage guide as an addition to the existing maps created by the MMR-HCS. The proponent will begin with a single booklet of the Fort area, as a pilot project. However, the project is conceived as a series of booklets accompanying the existing maps and future maps to be conceived, thus creating a set. The curation will be sub-precinct wise, culminating in four walks/trails as indicated in the maps. It will cover the heritage not only on trail routes but also in the vicinity. Thus, the Handbook will be complete with help of write-ups/narratives about the buildings, with illustrations and the map.

The approval of the project has been intimated to the project proponent with a request to submit 'Letter of Agreement' and 'Bank Guarantee' are awaited.

5.2 ON-GOING PROJECTS

The Board of Governors / Sub-Committee of the Society reviewed the progress reports of the following on-going projects:

(a) "Forgotten Gods and Deserted Strongholds – A Case Study of Europeans/Colonial Archaeology in the districts of Thane, Mumbai and Mumbai Suburban Districts with a part of Raigad District, especially Uran and Alibaug Talukas (1498-1818)"
by Shri. Mayur Thakare

Date of Approval: August, 2013 Grant: 4.75 Lakh Project duration: one year

The project aims to document the archaeological sites pertaining to Indo-European sites, all Portuguese and British sites in the category of Defensive/Religious/Civil in the districts of thane, Mumbai Sub-urban and Raigad, falling in the time bracket of 1498-1818 AD, to document important sites/monuments pertaining to regional power too, which had witnessed significant events during their relations with Portuguese and British.

A total of 105 sites were identified. The proponent has submitted a report with documentation of 69 of these rare and previously undocumented sites. The typology of sites documented includes Portuguese watch towers, outposts, step-wells, church complexes, fortified mansions, bastions- circular, square, pentagonal, fragments of fort walls, fortress etc. Since, they have not been identified so far, they are in neglected and dilapidated condition and require immediate attention.

Documentation is ongoing for the remaining 36 sites. Considering the time and effort put in by the proponent and the pioneer work of identification of these rare sites, the Sub-Committee approved an additional grant of Rs. 1,75,000/-, which is to be released on submission of final report comprising a documentation of all 105 sites. A total amount of Rs. 2,40,000/- has been released till 31st March 2018. The final report is awaited.






(b) "Dissemination projects initiated by the MMR-HCS on consultancy basis"

1. Developing Heritage Circuit Maps in the MMR

The objective of this task is to identify and delineate five heritage routes across MMR from within the existing list of Heritage Buildings and Precincts, along with preparation of A1 size foldout circuit maps, printed on both sides with drawings, photographs and descriptions of sites etc. The documentation has to include various related aspects of the routes like transport, history, important features, infrastructure, important aspects related to heritage, complementary cultural heritage aspects (food, music etc) and promotion strategy.

Task 1: By Envirodesigners Pvt. Ltd.

Heritage circuit maps have been prepared for five sites – 1) Matheran Hill Circuit 2) Ulhas River & Archaeological Sites Circuit 3) Alibaug and Pen Town 4) Fort Precinct of Mumbai 5) C – Ward of Mumbai. The final maps were reviewed by the Board of Governors and the work was found satisfactory. The final maps are to be printed for dissemination. A total amount of Rs. 5,35,315/- (including service tax) has been released.

2. Developing a Synoptic Document of Heritage in the MMR from the existing studies- by Adarkar Associates

The objective of the task is to develop a synoptic document from all the previous studies of identification and listing of heritage sites in the various parts of MMR towards:

- a) Building comprehensive understanding of heritage sites in the MMR
- b) Developing a history of the region through its built form

Over the course of the year, the consultant presented the draft of the final eight chapters of the Synoptic document. These chapters were reviewed by the Sub-Committee

and the Consultant was suggested some revisions regarding the graphic design of the manuscript, to make it more coherent and legible. The final manuscript incorporating these comments and suggestions is awaited.

A total amount of Rs. 10,24,896 (including service tax) has been released. The remaining amount of Rs. 2 Lakhs out of the earlier approved additional amount of Rs. 4 Lakhs is due to be released subject to receipt of the final draft of the Synoptic document by the Consultant.

(c) "Documentation of Caves in MMR"-

by Sathaye College, Mumbai

Date of Approval: March, 2015 Grant: Rs 10. 714 Lakh Project duration: Two year


MMR region has around 200 caves, a few of which are recently dicovered and have not been documented. Existing studies are often not comprehensive and a holistic approach to documentation is missing. The project proposes to document the newly discovered caves and related sites by making plans, sections and elevations for study and for better understanding of its architecture.

The proponent aimed to compile scattered information systematically with a holistic approach and even study the cultural context as reflected through the archaeological sources, monuments and oral traditions whilst providing analytical notes. The publication is envisaged as the final output, which will benefit not only the common man but it benefit scholars working in the field of archaeology, art history, epigraphy, iconography etc.

The final stage of the project is ongoing. Out of 11 cave complexes originally envisaged to be documented, two cave complexes could not be documented, due to difficulty experienced in accessing them. Draft reports have been submitted for six cave complexes. Final report on Brahmanical caves and draft reports on major and minor Buddhist caves was discussed in the meeting of the Sub-Committee. The Sub-Committee gave suggestions towards maintaining consistency in drawings; using a standard format, constant rendering style etc. The work on Kanheri and Kothaligad caves is underway.

The subject matter of the project has not been studied in detail earlier. The main objective of this project is to identify, research and analyze the art involved in Marathi theatrical backdrops; to enumerate the various artists involved with production of theatrical backdrops and finally to formulate a coffee-table book for publication. The artists and the art of creating theatrical backdrops have not been brought into the public domain. Due to the onset of modernity in drama and its practices, the use of backdrops diminished rendering the art and artistry of its practice to oblivion.

The proponent has submitted the draft of five chapters of the project. The chapters had been reviewed by the Society's Office and the proponent was suggested to detail out the chapter 'Scientific documentation' to analysis of techniques of late Mr. V. V. Divkar.

A total amount of Rs. 4,00,000/- has been released so far. The final project report is awaited.

(e) "Development of Heritage Information System for MMR- HCS"-

by Convergence IT Services Pvt. Ltd., Mumbai

The Society had proposed to develop a system on the web platform, where the data is to be spatially located on a map. The objective of the project is to develop and deploy software for heritage information system, which will facilitate the tasks of digitization, cataloguing, management and disseminate the information of heritage monuments, which have been identified and listed by the MMR-HCS. The database includes a list of heritage structures and precincts along with details on its historical, cultural, physical signficance etc.

The first installment for the project has been released and work on creating the Heritage Information System with data on all the 2678 heritage structures/properties in MMR is underway and is hoped to be completed by August 2018.




5.3 CONCLUDED PROJECTS

The format of the maps was redesigned by the graphic designer Ms. Nisha Nair, People Place Project, who was paid a consultancy fees of Rs. 80,000/-. The revised format was approved by the Board of Governors for printing. The final approved maps have been printed and are ready to be disseminated pending their formal release.

6. TRAINING AND AWARENESS PROGRAMMES

"Capacity Development Programme in Built Heritage Studies & Conservation"

-In collaboration with Sir. J.J. College of Architecture & Chhatrapati Maharaj Vastu Sangrahalaya (CSMVS)

The MMR-HCS, in collaboration with Chhatrapati Shivaji Maharaj Vastu Sangrahalaya (CSMVS) and Sir J.J. College of Architecture (JJCOA), has been supporting a year-long diploma course on 'Built Heritage Studies and Conservation', for the past 5 years (2013-2018). The total budget outlay for the capacity development programme was Rs 1 crore considering budgetary support of Rs. 20 Lakh for each year. Since its commencement in 2013, the programme has attracted participants from different states across India. Over the last five years, the programme has attracted 218 participants from 10 different states, with the majority from Maharashtra. Since the inception, the programme has invited 53 experts from 12 cities coming from diverse backgrounds.

Inaugurated in August 2013, the 5th Capacity Development Programme for the academic year 2017-18 was successfully concluded in February 2018. Five different courses conducted through week long modules covered during the year 2017-18 are as follows:






